RELATING TO TRANSPORTATION; ENACTING A NEW SECTION OF THE NMSA 1978 TO REQUIRE INTERSTATE HIGHWAY ESCORT SERVICES TO MEET CERTAIN STATE REQUIREMENTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. INTERSTATE ESCORT SERVICES--INSURANCE
COVERAGE--STATE TAXES.--

A. An interstate highway escort service business shall register with the state corporation commission and submit proof to the commission that the highway escort business has at least one million dollars (\$1,000,000) in insurance coverage. The interstate highway escort business shall be required to maintain the insurance coverage in effect at all times it is doing business in New Mexico. An interstate highway escort business shall be subject to New Mexico state taxes.

For the purpose of this section, "escort service" В. means a person or other legal entity that operates one or more vehicles in the escort of wide loads or other extraordinary vehicular traffic for the purpose of providing a warning of potential hazards associated with the wide load or other extraordinary vehicle.
