2 (2) the cost of temporarily placing adjudicated
3 delinquent offenders and youthful offenders in the Cibola county
4 correctional facility; and

(3) the cost of placing adjudicated delinquent offenders and youthful offenders in a correctional facility in which the corrections department currently incarcerates female adult inmates, located in Grants. The correctional facility located in Grants may be used for the commitment of delinquent offenders and youthful offenders placed in the custody of the children, youth and families department, pursuant to a joint powers agreement entered into by the corrections department and the children, youth and families department.

B. Any unexpended or unencumbered balance remaining at the end of fiscal year 1997 shall revert to the general fund.

Section 2. EMERGENCY.--It is necessary for the public peace, health and safety that this act take effect immediately.
