16	Section 1. APPROPRIATION TO HOUSE INMATES CONTRACT
17	PROVI SI ONS
18	A. Two million dollars (\$2,000,000) is appropriated
19	from the general fund to the corrections department for
20	expenditure in fiscal year 1998 to contract with Cibola county
21	to house additional immates at the Cibola county corrections
22	center. Any unexpended or unencumbered balance remaining at the
23	end of fiscal year 1998 shall revert to the general fund.
24	B. The contract entered into pursuant to Subsection
25	A of this section shall provide:

(1) that the total number of state inmates
housed at the Cibola county corrections center shall equal five
hundred fifty-two medium security inmates and one hundred
seventy-six minimum restrict inmates; and

(2) that the corrections department shall not reduce the number of inmates housed at the Cibola county corrections center below the numbers specified in Paragraph (1) of this subsection unless it has first removed all similarly classified state inmates from all other state, private or county operated correctional facilities.

Section 2. EFFECTIVE DATE. -- The effective date of the provisions of this act is July 1, 1997.
