BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. TRANSPORTATION OF STUDENTS TO SPECIAL EVENTS OR
EXTRACURRICULAR ACTIVITIES. -- School districts shall not be
prohibited from transporting students in school-owned vans
equipped with seatbelts to special events or extracurricular
activities.
