16	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
17	Section 1. SHORT TITLEThis act may be cited as the
18	"WICHE Loan for Service Act".
19	Section 2. DEFINITIONSAs used in the WICHE Loan for
20	Service Act:
21	A. "commission" means the commission on higher
22	education; and
23	B. "student" means a New Mexico resident who attends
24	or is about to attend a graduate or professional program of
25	education through the auspices of the Compact for Western

1 Regional Cooperation in Higher Education. STUDENT EXCHANGE PROGRAM - TERMS OF STUDENT Section 3. 2 LOANS- - PAYBACK REQUIREMENTS. - -3 Α. Financial assistance by the state for the student 4 exchange program of the western interstate commission on higher 5 6 education shall be through a loan program established pursuant 7 to this section. A student may receive a loan of tuition 8 **B**. 9 assistance on the following terms: 10 the loan shall not exceed the amount (1)11 equivalent to the support provided through the compact per 12 discipline each year; and 13 the loan shall bear interest at the rate (2)14 of: 15 (a) eighteen percent per year if the 16 student completes his education and no portion of the principal 17 and interest is forgiven pursuant to Subsection E of this 18 section; and 19 (b) seven percent per year in all other 20 cases. **C**. The loan shall be evidenced by a contract between 21 the student and the commission acting on behalf of the state. 22 23 The contract shall provide for the payment by the state of a stated sum covering the cost of tuition assistance and shall be 24 25 conditioned on the repayment of the loan to the state, together . 113338. 1

with interest, over a period established by the commission. The contract shall provide further that immediately upon completion or termination of the student's education, all interest then accrued shall be capitalized.

D. Loans made to a student who fails to complete his education shall become due, together with interest, immediately upon termination of his education. The commission shall establish terms of repayment, alternate service or cancellation terms.

E. The contract shall provide that the commission shall forgive a portion of the loan principal and interest for each year that a loan recipient practices his profession in New Mexico. Loan principal and interest shall be forgiven as follows:

(1) loan terms of one year shall require one year of practice for each year of the loan. Upon completion of service, one hundred percent of the principal plus accrued interest shall be forgiven;

(2) loan terms of two years shall require one year of practice for each year of the loan. Upon completion of the first year of service, fifty percent of the principal plus accrued interest shall be forgiven; upon completion of the second year of service, the remainder of the principal plus accrued interest shall be forgiven;

(3) for loan terms of three years or more,

forty percent of the principal plus accrued interest shall be forgiven upon completion of the first year of service, thirty percent of the principal plus accrued interest shall be forgiven upon completion of the second year of service and the remainder of the principal plus accrued interest shall be forgiven upon completion of the third year of service; and

the commission may establish other (4) forgiveness terms for professionals providing service in serious 8 shortage areas.

F. Loan recipients shall serve a complete year in order to receive credit for that year. The minimum credit for a year shall be established by the commission.

If a student completes his professional education G. and does not return to New Mexico to practice his profession, the commission shall assess a penalty of up to three times the principal due, plus eighteen percent interest, unless the commission finds acceptable extenuating circumstances for why the student cannot serve. If the commission does not find acceptable extenuating circumstances for the student's failure to carry out his declared intent to practice his profession in New Mexico, the commission shall require immediate repayment of the unpaid principal amount of the loan plus accrued interest owed the state plus the amount of any penalty assessed pursuant to this subsection.

3	Section 4. COMMISSION POWERS AND DUTIESCONTRACTS
4	A. The commission may:
5	(1) arrange with other agencies for the
6	performance of services required by the provisions of Section 3

8	(2) sue in its own name for any balance due the
9	state from a student on a contract;
10	(3) cancel a contract made between it and a
11	student for a reasonable cause deemed sufficient by the

14	provisions of the WICHE Loan for Service Act.
15	B. The commission shall make an annual report to the
16	governor and the legislature prior to the regular session of its
17	activities pursuant to the WICHE Loan for Service Act, including
18	loans granted and paid back or fulfilled through the practice of
19	a profession in New Mexico; a list of the schools or colleges
20	attended by those receiving loans; and any other information the
21	commission deems pertinent.
22	C. The general form of the contract provided for in
23	Section 3 of the WICHE Loan for Service Act shall be prepared
24	and approved by the attorney general and signed by the student
25	and a designee of the commission on behalf of the state.

1	Section 5. FUND CREATEDMETHOD OF PAYMENTThe "WICHE
2	loan for service fund" is created in the state treasury. All
3	money appropriated for loans to students participating in the
4	student exchange program of the western interstate commission on
5	higher education shall be credited to the fund. All payments of
6	principal and interest on loans made pursuant to the WICHE Loan
7	for Service Act shall be credited to the fund. All payments of
8	money for loans shall be made upon vouchers signed by the
9	designated representative of the commission and warrants drawn
10	by the secretary of finance and administration.


