RELATING TO HEALTH CARE; REQUIRING MAMMOGRAMS FOR MEDICAID RECIPIENTS TO CONFORM TO CERTAIN STANDARDS; ENACTING A NEW SECTION OF THE PUBLIC ASSISTANCE ACT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. A new section of the Public Assistance Act is enacted to read:

"[NEW MATERIAL] MAMMOGRAMS FOR MEDICAID RECIPIENTS.--In providing coverage for mammograms under the medicaid program, the department shall ensure that:

- A. the solicitation of patients for mammograms shall be determined by the department after taking into consideration the recommendations of nationally recognized medical organizations; and
 - B. the payment that shall be made on behalf of the

medicaid program for a mammogram of a medicaid recipient shall be consistent with and not exceed the usual and customary charge that reflects the reasonable fair market value of the cost of a mammogram."
