### AN ACT

RELATING TO THE PUBLIC PEACE, HEALTH, SAFETY AND WELFARE; MAKING AN APPROPRIATION TO FUND STIPENDS FOR GRADUATE ASSISTANTS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Seven hundred forty-four thousand five hundred ten dollars (\$744,510) is appropriated from the general fund to the board of regents of New Mexico state university for expenditure in fiscal year 1998 for the purpose of funding stipends for graduate assistants. Any unexpended or unencumbered balance remaining at the end of fiscal year 1998 shall revert to the general fund.
