16	managed care plan as it relates to behavioral health services;

19	nonmedical, community-based programs for behavioral health
20	services, and the medicaid managed care proposal that includes
21	behavioral health services does not reflect this success; and
22	WHEREAS, the medicaid managed care plan proposed by the
23	human services department, as it relates to behavioral health
24	services, may fail and could cause the entire managed care
25	proposal to fail; and

WHEREAS, the proposed medicaid managed care proposal is and has been repeatedly opposed by consumers, advocates and providers in New Mexico;

NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO that behavioral health services and funds be removed from the medicaid request for proposals, the initial managed care contracts and the federal waiver proposal; and

BE IT FURTHER RESOLVED that the human services department appoint, by no later than May 1, 1997, a task force of consumers, advocates and providers to develop a plan to manage behavioral health services and funds that will fully integrate medicaid and state general funds, reflect managed care principles and administration, ensure full linkages to primary care services and assure maximum participation of consumers, family members and advocates in the development, implementation and oversight of the managed care system as it applies to behavioral health services; and

BE IT FURTHER RESOLVED that this plan be responsive to the treatment and rehabilitation needs and concerns of adults with mental illness or substance abuse related disorders and children and youth with, or at risk of, serious emotional or behavioral disturbances, neurobiological disorders or substance abuse disorders; and

BE IT FURTHER RESOLVED that this plan be designed for full implementation no sooner than July 1, 2000; and
