# A JOINT MEMORIAL

REQUESTING THE SUPREME COURT TO ADOPT A RULE REQUIRING ALL JUDGES TO RECEIVE DOMESTIC VIOLENCE TRAINING AS PART OF THEIR JUDICIAL EDUCATION.

WHEREAS, ninety-five percent of domestic violence victims are women; and

WHEREAS, forty-six percent of female homicides in New Mexico are the result of domestic abuse and over one-third of those victims had reported prior injuries; and

WHEREAS, the attorney general's task force on violence against women, the New Mexico domestic violence advisory council and the New Mexico medical society have studied issues related to domestic violence and determined that judicial training would help address the problem; and

WHEREAS, the court is the single most important impetus for

change and successful enforcement of current laws to protect victims of domestic violence; and

WHEREAS, several states require judicial training in domestic violence law;

NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO that the supreme court be requested to adopt a rule that requires judicial training in domestic violence law and victim assistance; and

BE IT FURTHER RESOLVED that copies of this memorial be transmitted to the justices of the supreme court.
