A JOINT MEMORIAL

REQUESTING THE GOVERNOR TO PROCLAIM MARCH 31 AS CESAR CHAVEZ DAY.

WHEREAS, Cesar E. Chavez was born on March 31, 1927 to

Juana and Librado Chavez, a merchant, farmer and postmaster for
a community near Yuma, Arizona; and

WHEREAS, Cesar grew up during the depression and, like so many others in that period, experienced the hardships and heartaches of his family's loss of their farm and business; and

WHEREAS, the Chavez family, as so many others, went to California as migrant farm workers; and

WHEREAS, as a migrant farm worker, Cesar grew up under circumstances that made it hard to get an education, have a permanent home or achieve many of the components of the American dream; and

WHEREAS, he decided to dedicate himself to helping his fellow farmworkers and became a spokesman for better working conditions, better pay and equal justice in the farm fields of America; and

WHEREAS, he was instrumental in getting the united farm workers of America founded in 1962; and

WHEREAS, he persevered through bitter confrontations, jailings and physical threats to his life and won many of the goals he had pursued for his fellow workers;

NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO that the governor be requested to proclaim an annual day of commemoration, March 31, as Cesar Chavez day; and

BE IT FURTHER RESOLVED that copies of this memorial be transmitted to the governor and to Helen Fabela Chavez.
