TREATY LAND CLAIMS COMMISSION.

WHEREAS, New Mexico has a unique history in the acquisition
of land ownership due to the substantial number of Spanish and
Mexican land grants that were an integral part of the
colonization and growth of this area of the country; and

WHEREAS, various provisions of the treaties signed under
prior sovereigns have not yet been fully implemented in the
spirit of Article VI of the constitution of the United States;
and

WHEREAS, congress did establish an Indian claims
commission, which successfully adjudicated hundreds of disputed
land possessions quietly; and
