## A JOINT MEMORIAL

REQUESTING THE CHILDREN, YOUTH AND FAMILIES DEPARTMENT TO STUDY
THE POTENTIAL FOR THE USE OF HORSES IN THE THERAPY AND CARE OF
CHILDREN FROM ABUSIVE FAMILIES.

WHEREAS, child victims of abuse have been so traumatized that reinitiating social relations and reentering the world of relatively normal human relationships is very difficult and fear inducing; and

WHEREAS, animal therapy has been demonstrated to offer positive effects on abused children, lessening the immediate trauma; and

WHEREAS, a study of children in the battered families facility in Clovis, New Mexico has shown that nine years of experience with the Hebron Arabians has helped children involved in the program refocus their emotional experiences away from the

traumatic to the healing afforded by animal therapy;

NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO that the children, youth and families department be requested to study the potential for using horses to help children who have been victimized by abuse to recuperate from their emotional experiences and reintegrate with society; and

BE IT FURTHER RESOLVED that the children, youth and families department report its findings and recommendations to the appropriate interim legislative committee by December 1, 1997; and

BE IT FURTHER RESOLVED that a copy of this memorial be transmitted to the secretary of children, youth and families.
