AN ACT

MAKING AN APPROPRIATION TO THE COMMUNITY CORRECTIONS GRANT FUND TO PROVIDE A GRANT TO A NONPROFIT CORPORATION FOR THE OPERATION OF A COMMUNITY-BASED PROGRAM THAT INITIALLY WILL PROVIDE REINTEGRATION SERVICES TO CRIMINAL OFFENDERS IN LOS ALAMOS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- One hundred sixty-five thousand dollars (\$165,000) is appropriated from the general fund to the community corrections grant fund for expenditure in fiscal year 1999 to provide a grant to a nonprofit corporation for the operation of a community-based program that initially will provide reintegration services to criminal offenders in Los Alamos, including criminal offenders who are veterans of military service. 1 shall be operated in accordance with the provisions of the  
2 Adult Community Corrections Act. Any unexpended or  
3 unencumbered balance remaining at the end of fiscal year 1999
