AN ACT

MAKING AN APPROPRIATION FROM THE GENERAL FUND TO THE PUBLIC
SCHOOL CAPITAL IMPROVEMENTS FUND; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --Six million one hundred
thousand dollars (\$6,100,000) is appropriated from the general
fund to the public school capital improvements fund for
expenditure in fiscal year 1998 and subsequent fiscal years
for the purpose of carrying out the provisions of the Public
School Capital Improvements Act. Any unexpended or
unencumbered balance remaining in the fund at the end of
fiscal year 1998 shall not revert to the general fund.

Section 2. EMERGENCY. --It is necessary for the public
peace, health and safety that this act take effect
immediately.
