AN ACT

RELATING TO STATE GOVERNMENT; REQUIRING STATE AGENCIES TO PUBLISH AT LEAST ONE TELEPHONE NUMBER IN THE GOVERNMENT SECTION OF EACH PUBLIC TELEPHONE BOOK IN THE STATE; MAKING AN APPROPRIATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. STATE AGENCIES--TELEPHONE NUMBERS-- PUBLISHING.--Every department, independent board and independent commission of the government of the state of New Mexico that has one or more telephone numbers shall cause to be published in the government section of each public telephone directory in the state at least one general information telephone number.

Section 2. APPROPRIATION.--Forty-eight thousand five hundred fifty dollars (\$48,550) is appropriated from the

1 general fund to the general services department for  
2 expenditure in fiscal year 1999 for the purpose of paying for  
3 the publication of state agency telephone numbers pursuant to

6 shall revert to the general fund.
