MAKING AN APPROPRIATION TO EXPAND THE WOMEN, INFANTS AND
CHILDREN FARMERS' MARKET NUTRITION PROGRAM

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --Twenty thousand dollars
(\$20,000) is appropriated from the general fund to the
department of health for expenditure in fiscal year 1999 for
the purpose of expanding the New Mexico women, infants and
children farmers' market nutrition program under the federal
Farmers' Market Nutrition Act of 1992 provided for in the
special supplemental food program for women, infants and
children. Any unexpended or unencumbered balance remaining at
the end of fiscal year 1999 shall revert to the general fund.
