BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --Nine thousand dollars
(\$9,000) is appropriated from the general fund to the local
government division of the department of finance and
administration for expenditure in fiscal year 1999 for the
purpose of purchasing materials and constructing a fence
around a historic cemetery in the village of Columbus in Luna
county. Any unexpended or unencumbered balance remaining at
the end of fiscal year 1999 shall revert to the general fund.
