RELATING TO HEALTH CARE; IMPROVING ACCESS TO GOVERNMENTAL
HEALTH CARE PROGRAMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. DETERMINATION OF ELIGIBILITY FOR CHILD HEALTH
ASSISTANCE PURSUANT TO TITLE 21 OF THE SOCIAL SECURITY ACT--
LOCATIONS OF ELIGIBILITY WORKERS. --Determinations of
eligibility for child health assistance pursuant to an
approved state plan under Title 21 of the Social Security Act
shall be made by state eligibility workers. To increase
accessibility for eligibility determinations, the workers
shall be located in:

A. local and district offices of the human
services department;

B. local and district offices of the department of
