AN ACT

MAKING AN APPROPRIATION TO THE ADMINISTRATIVE OFFICE OF THE DISTRICT ATTORNEYS TO PROVIDE TRAINING TO STAFF ATTORNEYS IN DISTRICT ATTORNEY'S OFFICES THROUGHOUT THE STATE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- One hundred twenty-one thousand five hundred dollars (\$121,500) is appropriated from the general fund to the administrative office of the district attorneys for expenditure in fiscal year 1999 for the purpose of providing training to staff attorneys in district attorney's offices throughout the state. All requests by district attorneys for training shall be approved by the administrative office of the district attorneys to ensure that the training is applicable to their respective job classifications and is consistent with minimum continuing
