BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

**Section 1. APPROPRIATION. -- Ten thousand dollars
(\$10,000) is appropriated from the general fund to the
judicial education center for expenditure in fiscal year 1999
to train newly elected public regulation commissioners in
administrative law. Any unexpended or unencumbered balance
remaining at the end of fiscal year 1999 shall revert to the
general fund.**
