B. The term "penalty assessment misdemeanor" does
not include any violation that has caused or contributed to
the cause of an accident resulting in injury or death to any
person.

C. When an alleged violator of a penalty assessment misdemeanor elects to accept a notice to appear in lieu of a notice of penalty assessment, no fine imposed upon later conviction shall exceed the penalty assessment established for the particular penalty assessment misdemeanor and no probation imposed upon a suspended or deferred sentence shall exceed ninety days.

D. A court shall allow an individual who is issued a citation for a civil traffic violation pursuant to this section to attend a defensive driving school in lieu of the civil penalties provided in this section. A person who . 121063.1
