RELATING TO OPEN MEETINGS; AMENDING THE OPEN MEETINGS ACT TO PROVIDE THAT MEETINGS OF THE LEGISLATURE ARE PUBLIC MEETINGS EXCEPT FOR PARTY CAUCUSES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 10-15-2 NMSA 1978 (being Laws 1974, Chapter 91, Section 2) is amended to read:

"10-15-2. STATE LEGISLATURE--MEETINGS.--

A. All meetings of a quorum of members of any committee or policy-making body of the [state] legislature held for the purpose of discussing public business or for the purpose of taking any action within the authority of or the delegated authority of [such] the committee or body are declared to be public meetings open to the public at all times.

B. The provisions of Subsection A of this section					
$[\frac{\text{shall}}{\text{o}}]$ do not apply to party caucuses, matters relating to					
personnel or matters adjudicatory in nature [or any bill,					
resolution or other legislative matter not yet presented to					
either house of the legislature or general appropriation					
bills.					
C. For the purposes of this section, "meeting"					
means a gathering of the members called by the presiding					
officer of a standing committee]. "
