**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:**

Section 1. APPROPRIATION. -- One hundred fifty thousand dollars (\$150,000) is appropriated from the general fund to the state department of public education for expenditure in fiscal year 1999 to provide or contract for expansion of the adult basic education programs and services in rural areas of the state. Any unexpended or unencumbered balance remaining at the end of fiscal year 1999 shall revert to the general fund.
