AN ACT

MAKING AN APPROPRIATION FOR GRADUATE STUDENT RESEARCH AT
CERTAIN POST-SECONDARY EDUCATIONAL INSTITUTIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --

A. Five hundred thousand dollars (\$500,000) is appropriated from the general fund to the commission on higher education for distribution in the following amounts to the following post-secondary educational institutions for expenditure in fiscal year 1999 for the purpose of graduate research projects and travel:

(1) two hundred sixty thousand dollars (\$260,000) to the board of regents of the university of New Mexico;

(2) one hundred sixty thousand dollars

1 (\$160,000) to the board of regents of New Mexico state
2 university;

3 (3) twenty thousand dollars (\$20,000) to the
4 board of regents of New Mexico highlands university;

5 (4) thirty thousand dollars (\$30,000) to the
6 board of regents of New Mexico institute of mining and
7 technology;

8 (5) fifteen thousand dollars (\$15,000) to the
9 board of regents of eastern New Mexico university; and

10 (6) fifteen thousand dollars (\$15,000) to the
11 board of regents of western New Mexico university.

12 B. Any unexpended or unencumbered balance
13 remaining at the end of fiscal year 1999 shall revert to the
14 general fund.
