MAKING APPROPRIATIONS FOR CERTAIN MUNICIPAL PROJECTS IN THE
CITY OF CARLSBAD IN EDDY COUNTY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --Two hundred fifty thousand
dollars (\$250,000) is appropriated from the general fund to
the local government division of the department of finance and
administration for expenditure in fiscal year 1999 to fund
completion of the managed growth and development comprehensive
plan for the city of Carlsbad in Eddy county. Any unexpended
or unencumbered balance remaining at the end of fiscal year
1999 shall revert to the general fund.

Section 2. APPROPRIATION. --Four hundred thousand dollars
(\$400,000) is appropriated from the general fund to the local
government division of the department of finance and
