AN ACT

**MAKING AN APPROPRIATION TO THE NEW MEXICO LIVESTOCK BOARD TO
CONTRIBUTE TO RESEARCH PROJECTS RELATED TO VESICULAR
STOMATITIS VIRUS IN LIVESTOCK.**

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

**Section 1. APPROPRIATION. -- One hundred thousand dollars
(\$100,000) is appropriated from the New Mexico livestock
board's cash balances to the board's interim receipts and
disbursements fund for expenditure in fiscal years 1999 and
2000 to contribute to research projects concerned with the
vesicular stomatitis virus in livestock. Any unexpended or
unencumbered balance remaining at the end of fiscal year 2000
shall revert to the New Mexico livestock board's general fund.**
