AN ACT

MAKING AN APPROPRIATION TO THE NEW MEXICO LIVESTOCK BOARD TO
IMPLEMENT THE LIVESTOCK INSPECTOR SERIES RECLASSIFICATION
PLAN; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Seventy-five thousand dollars
(\$75,000) is appropriated from the New Mexico livestock
board's cash balances to the board's interim receipts and
disbursement fund for expenditure in fiscal years 1998 through
2000 to implement the livestock inspector series
reclassification plan with salary changes consistent with
compa-ratio levels for those inspectors whose salaries are
currently within the range of their proposed grade and salary
increases up to a minimum level for those inspectors whose
current salaries are below the minimum of their proposed

1 grade. The positions shall be budgeted in the base budget
2 request for subsequent years. Any unexpended or unencumbered
3 balance remaining at the end of fiscal 2000 shall revert to
4 the New Mexico livestock board's general fund.

5 Section 2. EMERGENCY.--It is necessary for the public
6 peace, health and safety that this act take effect
7 immediately.
