AN ACT

MAKING AN APPROPRIATION FOR A FEASIBILITY STUDY AND PLANNING
IN NORTHWESTERN NEW MEXICO.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --

A. One hundred thousand dollars (\$100,000) is appropriated from the general fund to the New Mexico office of Indian affairs for expenditure in fiscal year 1999 in the following amounts and for the following purposes:

(1) seventy-five thousand dollars (\$75,000) to contract for a study to be conducted that will determine the feasibility of developing a business center in Mexican Springs in McKinley county; and

(2) twenty-five thousand dollars (\$25,000) to contract for rural community planning services for the
