AN ACT

MAKING AN APPROPRIATION TO THE NEW MEXICO COMMISSION FOR THE BLIND TO HIRE ADDITIONAL STAFF AND CONTRACT FOR THE OPERATION OF INDEPENDENT LIVING CENTERS FOR VISUALLY IMPAIRED AND HEARING-IMPAIRED PERSONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRI ATI ON. - -

One hundred seventy-eight thousand dollars (\$178,000) is appropriated from the general fund to the New Mexico commission for the blind for expenditure in fiscal year 1999 in the following amounts and for the following purposes:

- forty-eight thousand dollars (\$48,000) to (1) pay salaries and benefits for two additional full-time employees; and
  - **(2)** one hundred thirty thousand dollars

(\$130,000) to contract for the operation of four independent living centers for visually impaired and hearing-impaired persons. The centers shall be located in Santa Fe, Albuquerque, Farmington and Las Cruces.

B. Any unexpended and unencumbered balance remaining at the end of fiscal year 1999 shall revert to the general fund.
