AN ACT

RELATING TO THE LEGISLATURE; CREATING A LEGISLATIVE RESERVE
FUND TO PAY SESSION EMPLOYEES WHEN SESSION APPROPRIATIONS ARE
DELAYED OR VETOED; MAKING AN APPROPRIATION; DECLARING AN
EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. LEGISLATIVE SESSION RESERVE FUND. --

A. The "legislative session reserve fund" is created in the state treasury. Interest earned on investment of the fund shall be credited to the fund, and the fund shall not revert at the end of any fiscal year. Money in the fund is appropriated to the legislative council service to pay the salaries of temporary legislative session employees when passage and signing of House Bill 1 or similar legislation is delayed or is vetoed.

B. If money in the fund is not sufficient to pay the salaries of temporary session employees in full, or if the legislative council service believes that more than one pay period will have to be paid from the fund, the legislative council service shall pay a pro rata share of salary due to each employee in a pay period.

Section 2. APPROPRIATION. -- One million dollars

(\$1,000,000) is appropriated from the general fund to the legislative session reserve fund for expenditure in any fiscal year in which appropriations to pay temporary legislative session employees are delayed. Any unexpended or unencumbered balance remaining at the end of a fiscal year shall not revert to the general fund.

Section 3. EMERGENCY.--It is necessary for the public peace, health and safety that this act take effect immediately.
