18	24B NMSA 1978 may be cited as the "Landscape Architects Act"."
19	Section 2. A new section of the Landscape Architects Act
20	is enacted to read:
21	"[ <u>NEW MATERIAL</u> ] INACTIVE STATUSA certificate of
22	registration in good standing may be transferred to inactive
23	status upon written request to the board and payment of an
24	annual inactive status fee set by the board. The request

registration. The registrant shall not practice in New Mexico during the time the certificate of registration is inactive. A registrant may reactivate his certificate of registration upon submission of a renewal form provided by the board, the payment of the annual renewal fee for the current year, proof of continuing education units for the period of inactive status and any additional proof of competency required by the board." 8

Section 3. Section 61-24B-11 NMSA 1978 (being Laws 1985, Chapter 151, Section 11) is amended to read:

FEES.--The board shall establish a schedule "61-24B-11. of reasonable fees for applications, certificates of registration, temporary permits, [and] re-registration, <u>inactive status and late registration renewal</u> as follows:

the initial application fee shall be set in an A. amount not to exceed [fifty dollars (\$50.00)] one hundred dollars (\$100);

the initial certificate of registration fee **B**. shall be set in an amount not to exceed [ one hundred fifty dollars (\$150); and ] three hundred dollars (\$300);

the certificate of registration renewal fee С. shall be set in an amount not to exceed [ one hundred dollars (\$100) four hundred dollars (\$400);

the annual inactive status fee shall be set at D. one-half the renewal fee for the year; and


