Section 1. APPROPRIATION. -- Thirty-eight thousand dollars (\$38,000) is appropriated from the general fund to the children, youth and families department for expenditure in fiscal year 1999 for the purpose of funding a full-time juvenile probation and parole officer for De Baca county. Any unexpended or unencumbered balance remaining at the end of fiscal year 1999 shall revert to the general fund.
