AN ACT

RELATING TO MOTOR VEHICLES; PROVIDING FOR THE USE OF YEAR-OF-
MANUFACTURE LICENSE PLATES FOR ANTIQUE MOTOR VEHICLES;
ENACTING A SECTION OF THE MOTOR VEHICLE CODE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. A new section of the Motor Vehicle Code is
enacted to read:

" NEW MATERIAL YEAR-OF- MANUFACTURE LICENSE PLATES--
PROCEDURES-- FEES. --

A. The division may specially register and permit
the use of year-of-manufacture license plates on motor
vehicles thirty or more years old.

B. The division shall inspect the year-of-
manufacture license plate to ensure the plate is in good
condition and the number on the plate is not already assigned

1 or in use. To qualify for use, the year-of-manufacture plate
2 shall be an authentic plate issued in New Mexico during the
3 motor vehicle's model year.

4 C. For a one-time fee of twenty-five dollars
5 (\$25.00), which shall be in addition to the regular motor
6 vehicle registration fees, any owner of a motor vehicle that
7 is thirty or more years old may apply to the division to use a
8 year-of-manufacture plate on his vehicle.

9 D. Upon the sale or transfer of a motor vehicle
10 bearing a year-of-manufacture plate, and upon payment of a ten
11 dollar (\$10.00) transfer fee in addition to the regular motor
12 vehicle registration fees, the plate shall remain with the
13 vehicle and be transferred to the new owner.

14 E. Ten dollars (\$10.00) of the fee collected
15 pursuant to Subsection C of this section shall be retained by
16 the department and is appropriated to the department to defray
17 the cost of issuing the special year-of-manufacture
18 registration plates. "
