RELATING TO HEALTH; REQUIRING REGIONALIZATION OF MEDICALD MANAGED CARE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. MEDICAID MANAGED CARE--REGIONALIZATION
REQUIRED.--After July 1, 1998, any medicaid managed care
contract entered into by the human services department or any
other state agency shall not permit the provider to offer
services on a statewide basis, but must require the provider
to offer services only in a specific geographic region of the
state. A provider may provide services in more than one
region in the state. This regionalization of the medicaid
managed care program shall be structured by the department to
achieve maximum cost savings in the program's operation and
shall be designed to protect the operations and effective use

of local health care providers and facilities.
