AN ACT

RELATING TO STATE FINANCES; REPEALING THE PREMIUM TAX
LITIGATION SURCHARGE; REVERTING SEVERAL INACTIVE STATE

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
