AN ACT

MAKING AN APPROPRIATION TO PROVIDE EDUCATIONAL SERVICES AND
PURCHASE MATERIALS FOR THE AFTER SCHOOL ACADEMY FOR AT-RISK
STUDENTS AT ALAMOSA ELEMENTARY SCHOOL IN ALBUQUERQUE IN
BERNALILLO COUNTY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- One hundred thousand dollars
(\$100,000) is appropriated from the general fund to the state
department of public education for expenditure in fiscal year
1999 for the purpose of providing instructional services and
purchasing needed materials for the after school academy for
at-risk students at Alamosa elementary school in Albuquerque
in Bernalillo county. Any unexpended or unencumbered balance
remaining at the end of fiscal year 1999 shall revert to the
general fund.
