AN ACT

MAKING AN APPROPRIATION TO THE HUMAN SERVICES DEPARTMENT TO
PROVIDE SERVICES TO NEW CLIENTS UNDER THE WAIVER PROGRAM FOR
DEVELOPMENTALLY DISABLED PERSONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Three million dollars
(\$3,000,000) is appropriated from the general fund to the
human services department for expenditure in fiscal year 1999
to provide services for new clients not currently enrolled in
the waiver program for developmentally disabled persons. Any
unexpended or unencumbered balance remaining at the end of
fiscal year 1999 shall revert to the general fund.
