AN ACT

MAKING AN APPROPRIATION TO THE UNIVERSITY OF NEW MEXICO FOR  
THE NURSE-MIDWIFERY PROGRAM; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Three hundred fifty thousand dollars (\$350,000) is appropriated from the general fund to the board of regents of the university of New Mexico for expenditure in fiscal years 1998 and 1999 to continue the nurse-midwifery program in the college of nursing. Any unexpended or unencumbered balance remaining at the end of fiscal year 1999 shall revert to the general fund.

Section 2. EMERGENCY. -- It is necessary for the public peace, health and safety that this act take effect immediately.
