AN ACT

MAKING AN APPROPRIATION TO THE CHILDREN, YOUTH AND FAMILIES
DEPARTMENT FOR THE DEVELOPMENT AND IMPLEMENTATION OF A PROGRAM
OF MEDICAL DAYCARE SERVICES FOR CHILD CARE OF SICK CHILDREN OF
WORKING PARENTS; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Two million four hundred
thousand dollars (\$2,400,000) is appropriated from the general
fund to the children, youth and families department for
expenditure in fiscal years 1998 and 1999 for the purpose of
developing and implementing a program of medical daycare
services for child care of sick children of working parents.
Any unexpended or unencumbered balance remaining at the end of
fiscal year 1999 shall revert to the general fund.

Section 2. EMERGENCY. -- It is necessary for the public
