AN ACT

MAKING AN APPROPRIATION TO THE ENERGY, MINERALS AND NATURAL
RESOURCES DEPARTMENT TO ASSIST LOW-INCOME INDIVIDUALS TO
CONSERVE ENERGY THROUGH HOME WEATHERIZATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- One million dollars
(\$1,000,000) is appropriated from the general fund to the
energy, minerals and natural resources department for
expenditure in fiscal year 1999 for the purpose of
weatherizing homes for persons whose incomes are at or below
one hundred twenty-five percent of the federal income poverty
guideline. Any unexpended or unencumbered balance remaining
at the end of fiscal year 1999 shall revert to the general
fund.
