BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Fifty thousand dollars  
(\$50,000) is appropriated from the general fund to the board  
of regents of the university of New Mexico for expenditure in  
fiscal year 1999 for the purpose of funding start-up costs for  
new classes at the graduate center at the Gallup branch of the  
university of New Mexico. Any unexpended or unencumbered  
balance remaining at the end of fiscal year 1999 shall revert  
to the general fund.
