MAKING AN APPROPRIATION FOR THE NAVAJO NATION CHILD SUPPORT
ENFORCEMENT PROGRAM

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- One hundred fifty thousand
dollars (\$150,000) is appropriated from the general fund to
the human services department for expenditure in fiscal year
1999 for the Navajo nation child support enforcement program.
Any unexpended or unencumbered balance remaining at the end of
fiscal year 1999 shall revert to the general fund.
