AN ACT

MAKING AN APPROPRIATION TO THE UNIVERSITY OF NEW MEXICO FOR
HEALTH EDUCATION AND FOR POPULATION HEALTH RESEARCH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --

A. Six hundred thirty-five thousand dollars
(\$635,000) is appropriated from the general fund to the board
of regents of the university of New Mexico for expenditure in
fiscal year 1999 for the following purposes:

(1) two hundred sixty-five thousand dollars
(\$265,000) for the area health education center to support
students in health care professions receiving training in
rural and underserved areas of the state; and

(2) three hundred seventy thousand dollars
(\$370,000) for population health research, education and
