AN ACT

MAKING AN APPROPRIATION TO THE BOARD OF REGENTS OF THE
UNIVERSITY OF NEW MEXICO TO CONTRACT FOR THE OPERATION OF A
STATEWIDE PROGRAM THAT PROVIDES RECREATIONAL, EDUCATIONAL AND
CULTURAL ACTIVITIES FOR AT-RISK YOUTHS AND THEIR FAMILIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Six hundred thousand dollars
(\$600,000) is appropriated from the general fund to the board
of regents of the university of New Mexico for expenditure in
fiscal years 1999 through 2001, to be expended in the amount
of two hundred thousand dollars (\$200,000) during each fiscal
year, for the purpose of contracting for the operation of a
statewide program that provides recreational, educational and
cultural activities for at-risk youths and their families. An
evaluation of the program's effectiveness shall be conducted
