MAKING AN APPROPRIATION TO THE COMMUNITY COLLEGE BOARD OF
SANTA FE COMMUNITY COLLEGE FOR IMPLEMENTING A MATHEMATICS AND
SCIENCE CONCURRENT ENROLLMENT PROGRAM

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --Forty-eight thousand three
hundred forty-five dollars (\$48,345) is appropriated from the
general fund to the community college board of Santa Fe
community college for expenditure in fiscal years 1998 and
1999 for the purpose of implementing a mathematics and science
concurrent enrollment program. Any unexpended or unencumbered
balance remaining at the end of fiscal year 1999 shall revert
to the general fund.
