AN ACT

RELATING TO CRIMINAL LAW; EXPANDING THE LIST OF PREDICATE
OFFENSES FOR THE CRIME OF RACKETEERING; AMENDING A SECTION OF
THE RACKETEERING ACT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 30-42-3 NMSA 1978 (being Laws 1980,
Chapter 40, Section 3, as amended) is amended to read:

"30-42-3. DEFINITIONS. -- As used in the Racketeering Act:

A. "racketeering" means any act which is
chargeable or indictable under the laws of New Mexico and
punishable by imprisonment for more than one year, involving
any of the following cited offenses:

(1) murder, as provided in Section 30-2-1
NMSA 1978;

(2) robbery, as provided in Section 30-16-2

18 (22) altering or changing engine numbers or
19 other motor vehicle numbers, as provided in Section 66-3-508
20 NMSA 1978;

21 B. "person" [~~includes~~] means any individual or
22 entity capable of holding a legal or beneficial interest in
23 property;

24 C. "enterprise" means any sole proprietorship,
25 partnership, corporation, business, labor union, association

1 or other legal entity or any group of individuals associated
2 in fact although not a legal entity and includes illicit as
3 well as licit entities; and

4 D. "pattern of racketeering activity" means
5 engaging in at least two incidents of racketeering with the
6 intent of accomplishing any of the prohibited activities set
7 forth in Subsections A through D of Section 30-42-4 NMSA 1978;
8 provided at least one of [~~such~~] the incidents occurred after
9 the effective date of the Racketeering Act and the last [~~of~~
10 ~~which~~] incident occurred within five years after the
11 commission of a prior incident of racketeering. "

12 Section 2. EFFECTIVE DATE. --The effective date of the
13 provisions of this act is July 1, 1998.
