AN ACT

RELATING TO THE PUBLIC EMPLOYEE LABOR RELATIONS BOARD;
PROVIDING THE BOARD'S BUDGET APPROPRIATION; REPEALING SUNSET
PROVISIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- One hundred eighty-eight thousand eight hundred dollars (\$188,800) is appropriated from the general fund to the public employee labor relations board for expenditure in fiscal year 1999 in the following budget categories. Any unexpended or unencumbered balance remaining at the end of fiscal year 1999 shall revert to the general fund. Figures are in thousands of dollars:
