AN ACT

MAKING AN APPROPRIATION FOR A FULL-TIME HONOR GUARD AND BUGLER
AT THE SANTA FE AND FORT BAYARD NATIONAL CEMETERIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Fifteen thousand dollars
(\$15,000) is appropriated from the general fund to the New
Mexico veterans' service commission for expenditure in fiscal
year 1999 for the purpose of providing a full-time honor guard
and bugler at the Santa Fe and the Fort Bayard national
cemeteries. Any unexpended or unencumbered balance remaining
at the end of fiscal year 1999 shall revert to the general
fund.
