AN ACT

MAKING AN APPROPRIATION FOR HIGH SCHOOL EDUCATION PROGRAMS FOR
AT-RISK TEENAGE PARENTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Three million seven hundred
fifty-five thousand five hundred dollars (\$3,755,500) is
appropriated from the general fund to the vocational education
division of the state department of public education for
expenditure in fiscal year 1999 for the purpose of providing
high school education programs for at-risk teenage parents
statewide. Funding shall be used to provide classes in basic
parenting, nutrition and hygiene skills as well as child care
for teenage parents. Any unexpended or unencumbered balance
remaining at the end of fiscal year 1999 shall revert to the
