AN ACT

MAKING AN APPROPRIATION FOR GRADUATE RESEARCH PROJECTS
STATEWIDE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --

A. Five hundred thousand dollars (\$500,000) is appropriated from the general fund to the governing bodies of the following institutions for expenditure in fiscal year 1999 in the following amounts for the purpose of funding graduate student research:

(1) two hundred sixty thousand dollars (\$260,000) to the board of regents of the university of New Mexico;

(2) one hundred sixty-five thousand dollars (\$165,000) to the board of regents of New Mexico state

(3) thirty thousand dollars (\$30,000) to the board of regents of New Mexico highlands uni versi ty;

(4) twenty thousand dollars (\$20,000) to the board of regents of New Mexico institute of mining and technology;

(5) fifteen thousand dollars (\$15,000) to the board of regents of eastern New Mexico university; and

(6) ten thousand dollars (\$10,000) to the board of regents of western New Mexico university.

B. Any unexpended or unencumbered balance remaining at the end of fiscal year 1999 shall revert to the general fund.
